ORDER N° 44 /DGSN/SG/DARH/SDROPS/SR.-

To launch a special competitive examination for the recruitment into the first year of the National Advanced Police School of **50 CADET ASSISTANT SUPERINTENDENTS OF POLICE.**

THE PRESIDENT OF THE REPUBLIC,

- Mindful of the Constitution;
- Mindful of Decree n°2011/412 of 09 December 2011 to reorganize the Presidency of the Republic;
- Mindful of Decree n°96/034 of 1st March 1996 to create the General Delegation for National Security;
- Mindful of Decree n°2011/540 of 19 November 2012 to organize the Presidency of the Republic;
- Mindful of Decree n°94/199/ of 7th October 1994 relating to the General Rules and Regulations governing the Public Service;
- Mindful of Decree n°2012/539 of 19th November 2012 relating to the Special rules and Regulations governing the National Security Corps;
- Mindful of Decree n°75/496 of 3rd July 1975 to determine the nature of administrative examinations and subsequent modifications;
- Mindful of Decree n°75/459 of 26th June 1975 to determine the remuneration of civil and military personnel of the Republic of Cameroon, as modified by Decree n°79/64 of 3rd March 1979 ;
- Mindful of Decree n°2010/263 of 31 August 2010 to appoint the Delegate General for National Security;
- Mindful of Decree n°2010/280 of 13 September 2010 to grant permanent delegation of signature to **Mr Martin MBARGA NGUELE**, Delegate General for National Security;
- Mindful of Decree n°2012/545 of 20 November 2012 relating to the organisation and functioning of the National Advanced Police School and Police Training Centres;
- Mindful of Order n°204/CAB/PR of 16 April 2003 relating to admission requirements into the various cycles, nature and conditions of study at the National Advanced Police School and Police Training Centres, as modified and completed by Order No. 913/CAB/PR of 15th September 2014 ;
- considering service imperatives;

HEREBY ORDERS AS FOLLOWS:

ARTICLE 1.- (1) A special competitive examination for the recruitment into the 1st year of National Advanced Police School of **50 Cadet Assistant Superintendents of Police** shall be launched on **22nd January 2022.**

(2) The exam shall concern only Civil Servants of the National Security Corps who shall fulfil the requirements laid down by this order.

I – GENERAL AND SPECIFIC REQUIREMENTS:

Prospective candidates shall fulfil the following specific requirements to qualify for the competitive examination. They shall:

- ⇒ Be Civil Servants of the National Security Corps duly integrated into one of the ranks of the corps by the date of the examination;
- ⇒ Be holders of the General Certificate of Education, (Advanced Level) with a pass in at least two papers, obtained in one sitting excluding RELIGIOUS KNOWLEDGE, "le Baccalauréat de l'Enseignement Général", or any other equivalent certificate.
- ⇒ Not have any sanction which is still in force ;
- ⇒ Enjoy their civic rights ;
- ⇒ Not have been sentenced for a felony or a misdemeanour touching on probity notably, theft, forgery, influence peddling, false pretence, corruption, embezzlement of public funds and misappropriation; for more than 6 months in prison or for any offence as stipulated in Section 30, paragraphs 1 and 6 of the Cameroon Penal Code.

(3) Candidates shall fulfil all these requirements; failure to comply with any of these requirements shall automatically lead to the rejection of their files.

II – REQUIRED DOCUMENTS:

ARTICLE 2 - (1) Prospective candidates shall, prior to the compilation of their documents, register online via the website www.dgsn-cm.org, from **30th November to 30th December 2021** at 3.30 p.m. prompt.

ARTICLE 3- (1) Candidates whose online registration shall be validated shall submit their complete file to the General Delegation for National Security in Yaounde, or at any of the Regional Delegations for National Security following a schedule that shall be made known to them by phone.

Application files shall include:

1. A handwritten application with date and signature, and bearing a fiscal stamp of 1000 CFA francs, addressed to the Delegate General for National Security. The application shall clearly state:

- The candidate's full name, address, sex, date and place of birth;
- Division and Region of origin ;
- The chosen competitive examination ;
- National Identity Card number or valid Temporary Identity Document number ;
- The list of enclosed documents.

2. A copy of the integration decision certified by the Sub-Director of Administrative Management of the General Delegation for National Security. Candidates pending integration shall have an attestation issued to them by the Sub-Director of Administrative Management which shall bear the reference of the integration file forwarded to the Presidency of the Republic;

3. An online registration form, printed from the above-mentioned website, and duly filled in and signed by the candidate with two passport size (4x4) colour photographs taken on a white background ;

4. A receipt of payment of **21 000 CFA francs** for registration, issued by any branch of **EXPRESS UNION** ; or through **ORANGE MONEY, MTN MOBILE MONEY** or **EXPRESS UNION MOBILE MONEY**, after obtaining the payment code in accordance with procedure described on the website www.dgsn-cm.org

The payment receipt or the lone transaction number acknowledging the payment of the competition fees shall be enclosed to the application file;

5. A certified copy of the candidate's Birth Certificate issued within six (6) months;

6. A certified true copy of the required certificate, signed by a competent authority;

7. A certificate of presentation of the original of the diploma signed by a competent authority;

8. A large (A4) envelop bearing the candidate's address with a standard postage stamp;

(2) Any incomplete file shall be simply rejected at the General Delegation for National Security and send back to the applicant.

(3) At each phase the General Delegation for National Security shall publish lists of authorized candidates and only such shall be considered authentic.

III - LONE EXAMINATION CENTRE: YAOUNDE

ARTICLE 4.- Candidates shall be expected in front of their examination rooms, 30 minutes before the beginning of first subject, with their National Identity Cards and receipts issued upon submission of their files. They shall not be allowed into the examination rooms with any piece of paper or book; writing and rough work sheets shall be provided by the Administration.

IV - THE EXAMINATION:

ARTICLE 5.- (1) The competitive examination shall comprise a written part and an interview, scored on a scale of 0 to 20 with varying coefficients.

(2) Candidates for the special competitive examination shall be exempt from medicals, physical fitness test, and character investigations.

A) – THE WRITTEN EXAMINATION:

The programme of the written part of the examination is annexed to this order and shall take place at the **lone centre of YAOUNDE** per the following schedule:

For candidate to be declared successful in the written examination, they shall have and average score of 12/20, without an eliminatory mark in any of the subjects.

B) – THE INTERVIEW:

Candidates declared successful in the written examination shall report for an interview at the **lone centre of YAOUNDE.**

The oral questions relate to both the examination programme and topical issues. After a brief preparation on a selected question, the eligible candidate shall perform a 10-minute presentation, followed by a 10-minute interview with the jury (coef.2).

V – FINAL RESULTS:

ARTICLE 6.- The final results of the competitive examination shall be released by the Delegate General for National Security.

ARTICLE 7.- Only candidates who shall have the required average mark, without an eliminatory mark, shall be declared successful. They shall be enlisted into 1st year of the National Advanced Police School as Cadet Assistant Superintendents of Police by the competent authority.

ARTICLE 8.- The present order shall be registered and published in the Official Gazette, in English and French.-
